

Complete Rules of the Consumer Contest

The purpose of this document is to fully and clearly define the rules of the contest run by CREATIVE FRIENDS s.r.o. on the web platform provided by Engramo Project s.r.o. (hereafter as "Contest"). These rules are meant to complement the information concerning the rules of the Contest ("Contest Information") as published by the Organiser (see below) on the Engramo web platform where the Contest is run (hereafter as "Platform")

The Contest is run by: CREATIVE FRIENDS s.r.o., Husinecká 903/10, Žižkov, 130 00 Praha 3, IN: 06377661, registered at the Prague Municipal Court in section C of the business register, insert 281223 (hereafter as "Organiser").

Time and Place of the Contest

The Contest will be taking place on the website https://kvizovani.waltrovka-work.cz between March 29, 2021, and April 1, 2021, in the Czech Republic.

Contest Participants

Only natural persons over the age of 18 with a postal address in the European Union who also meet any other potential conditions set out at https://kvizovani.waltrovka-work.cz/awards_en.html may take part in the Contest (hereafter as "Participant", "Contest Participant" and "Contestant").

All persons employed or similarly contractually bound by the Organiser and/or the companies PRG Aviatica s.r.o., PRG Mechanica s.r.o., and/or PRG Dynamica s.r.o. are disqualified from participation in the Contest.

Those who do not meet the conditions for participation in the Contest or who act in violation of the rules of the Contest will not be eligible to participate.

Win Conditions

The conditions for winning and the rules under which the order of the winners will be determined are available among the Contest information published at https://kvizovani.waltrovka-work.cz/awards_en.html.

The Contest information also details the actual prizes to be won. The delivery of the prize to the winner will be handled mostly by a third party delivery service operating in the Capital City of Prague and/or the Central Bohemian Region, unless the Contest information specifies otherwise.



Personal Data Processing

By participating in the Contest the Participants acknowledge the processing of the personal data provided by the Participant to the Organiser for the purposes of running the Contest (i.e.

administrating it, organising it, assessing it), announcing the winner(s) (especially on the Organiser's website and social media) and contacting the winner(s) due to the legitimate interest in realisation of the Contest that the Organiser has.

The Participants acknowledge that they provide their personal data voluntarily and that they have the right to access their personal data as well as the right to rectification of said personal data and to blocking of incorrect personal data, and finally the right to object to the processing of personal data.
